**East Khasi Hills**



On April 12th, 2023, a site inspection was carried out of the interventions under Catalytic Fund being executed by the VECs Kyndong Laitmawbah and Mawkohtep, situated in the Mawphlang Block. The project involves the construction of an irrigation canal and check dam. Following consultation with the VECs, it was confirmed that the project is scheduled to be finalized by April 2023. An APO from the Mawphlang Block was present during the field inspection.



The EKH team conducted a site inspection of the completed activities at Thangsning VNRMC, located in the Mawkynrew Block. The activities inspected included the retaining wall, spring chamber, and protection wall, which were implemented using the additional funds of CNRMP. Additionally, the ongoing training hall was noted to have been constructed according to the plan and estimate, utilizing the excess funds.

On April 12th, 2023, the GIS EKHD Team undertook the collection and verification of forest area demarcation for PES Phase 2 in the Shella block. The team then proceeded to conduct the same activity in the Pynursla block on the following day.



The community of Umkhoi Village was engaged in a meeting to discuss Sadhana Forest's roles and objectives. The meeting was facilitated by the Social Manager of East Khasi Hills, along with the DPM on April 14, 2023.



On April 14, 2023, master trainers, including the VCFs from CLLMP, SCALE program, and MEGLIFE, received training on forest management plans.

A planning and review meeting cum orientation for VCFs (PES verification) was held at CLLMP office (Mawkyrwat), with a target set to complete all applications before May 15th, 2023.

A visit was made to Pyndengumjarain to oversee the implementation of FMP and hold meetings with the VNRMC to assist them in better understanding how to distribute the work and funds to all beneficiaries in their respective villages. The implementation has started, and some activities have been completed. The VNRMC had their doubts and problems cleared up to their understanding. Checking on the implementation of pending CNRM activities at Pyndengumjarain was also done. Pyndengumjarain also received a traditional hall and has agreed to start the implementation process.

On April 13th, 2023, the District Project Manager, Deputy Manager-M&E, AM-SM, and EE-Social had a meeting with the EC members of VNRMC at Laitnong. The meeting discussed the need to settle pending payments for all completed activities, checked the book of records, and visited the Traditional Hall (Excess Fund). Suggestions and guidance were provided to the VNRMC members regarding the proper finishing touch on the ongoing construction of the Traditional Hall.

On April 12th, 2023, a field visit was conducted to Saka Boldamgre, Dopogre, and Okkapara Songgitcham under the Gambegre Block. The purpose of the visit was to inspect ongoing and completed activities, as well as damaged structures, under CLLMP-DPM, with the presence of Deputy Manager-EM and Field Engineer.



On April 14th, 2023, a Forest Management Plan (FMP) training was held for Garo Hills Village Community Facilitators (VCFs) at SMELC in Tura. Conducted by CLLMP Master Trainers from various districts, topics covered included Forest Inventory, GPS, and Forestry Survey.

A hands-on field demonstration was held in Upper Dopgre Village for survey techniques, tree enumeration, and data collection. A total of 27 VCFs and 18 CLLMP staff attended the training.

## For A Better Tomorrow

### Nongbah Nongnah

#### **Introduction**

Nongbah Nongnah is located in South West Khasi Hills District. It is situated about 40 kms from Mawkyrwat which is the Headquarter of the District. It is the oldest village in Nongnah area. Nongbah has a total of 45 households and the residents of this village as we the DPMU team have seen are the most hard working and sincere people as one of the Non-CLLMP village we have had the opportunity to work with.

The people here are mostly engaged in farming activities and they are busy all year round. They cultivate broomstick, pepper, oranges and areca nut on a large scale. Their main source of income is broomstick. The only time they are most free is from the month of September to December and during this time they complete all their works in the village from various departments.

The Community Led Landscape Management Project throughout its five years here in South West have seen and met many people in and around but, the people of Nongbah Nongnah have struck our hearts as their will, hard work and determination can be seen in their work of which they are a recipient of the Catalytic Fund.

Catalytic Fund is a fund given to villages with potential towards natural resources management.

## Earlier Case Finding

Mot Chaw Long- The first residents of Nongbah Nongnah are the Clan (Kur) Lyngkhoi and in the heart of the village the clan elders have erected stones to commemorate Long Lyngkhoi as the ‘mother’ of the Lyngkhoi clan in Nongbah Nongnah. They did this as they did not know how to write at that time and this was the only way to honor her and to remember her name forever.

Phot Riat- This source of water founded by the forefathers of the village might be the only perennial spring water in the village. Even up to March the water stays and refills just enough so the villagers can scoop water with a mug or a bowl. It takes about half an hour for a women or child from the centre of the village to fetch water from Phot Riat. The spring name Phot Riat (local dialect) roughly translates to ‘a spring in a steep hill (here, very steep)’. There has also been a sad occurrence where a lady from the village went to fetch water from the spring fell to her death as the cliff on the hill is very steep. Though people till now have not stopped fetching water from there as they depend on it for drinking and cooking.

## Intervention

The VEC with a strong will to receive help approached the CLLMP office in Mawkyrwat as they have known about CLLMP from their neighboring village that fall under CLLMP’s project. As the DPMU team sat and talked with members of the VEC they understood their hardships and decided to help them.

A trip was made to Nongbah Nongnah by the team and site inspections were done and after much brainstorming along with the VEC members who accompanied them, solutions and ideas were had on how to tackle some of the hardships faced by the people. Soon enough after everything had been finalized by the team the ideas had turned into reality and everything planned was set on foot.

Plantation works, boulder bund boxes and half-moon terraces have been proposed at Mot Chaw Long to help preserve the area because as time passes by the area might be forgotten and destroyed. The community worked hard on these activities and showed much interest as they too wanted to preserve the area for many generations to come. They even dressed the stones they used for the boulder bund themselves so as to add aesthetic beauty to the area. Half-moon terrace was done for planting trees to retain moisture and for easy application of fertilizers and manures for healthy growth of plants.

Since the main problem faced by the community is water scarcity and the area is rocky so the water cannot seep underground much making it dry so the team along with the VEC decided that a check dam was necessary not far away from the village. The site at Synrang Manai was satisfactory and the intervention was made. The aim of the check dam was to help tackle the water problems of the community by storing water during the summers which can be used domestically when winter season starts. It also helps recharge ground water and replenish underground aquifers. The check dam will surely prove to be a boon for the community as they have given their all and even made lots of community contributions towards building it

At Phot Riat the want of the team to intervene was even greater as it is the only perennial spring in the village and the loss of a life has put an even greater concern for the safety of the people from the village and the neighbouring village who fetch water from here. A spring chamber was made at the source as it was an open spring before. This will keep the water clean and free from the debris around it. Safety rails were also constructed along the cliff side of the path leading up to the spring

Through all these activities the community have worked very hard and tirelessly and have shown great interest in looking at different side of things too especially in preserving and conserving what nature or mankind have given to them and they also feel that along with the external help they receive they too will have to make community contributions and give maximum effort if they want things to be done perfectly.

The VEC and the community as a whole are very grateful towards the World Bank for all the help given to them and are also thankful to the DPMU team for their hard work and willingness to visit the sites and intervene. CLLMP's journey in the village though it was small made a huge and significant impact on the environment and the people as a whole.

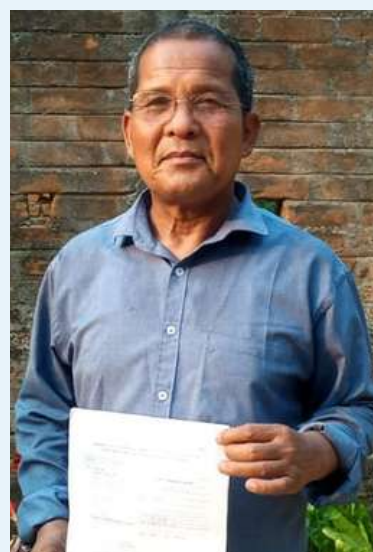

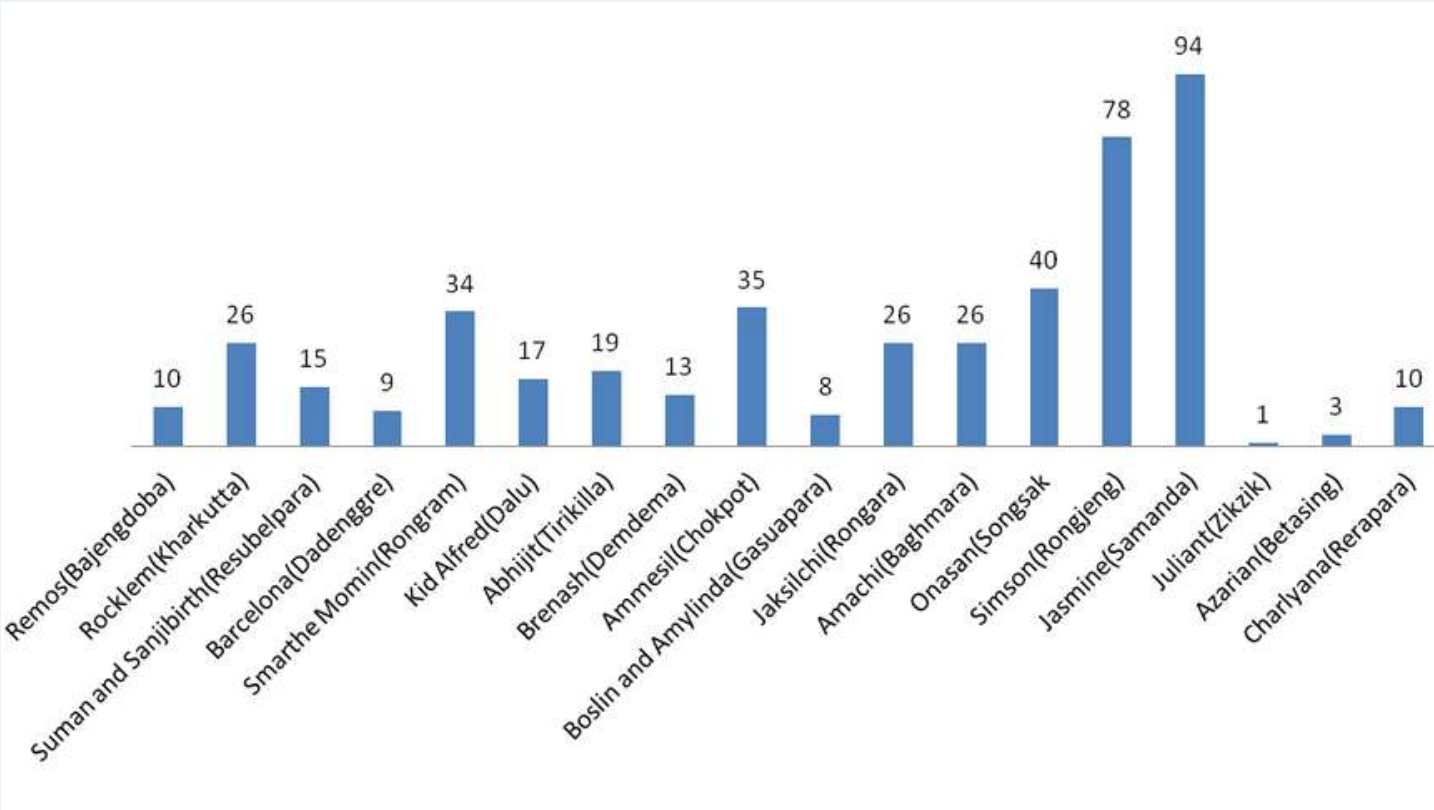

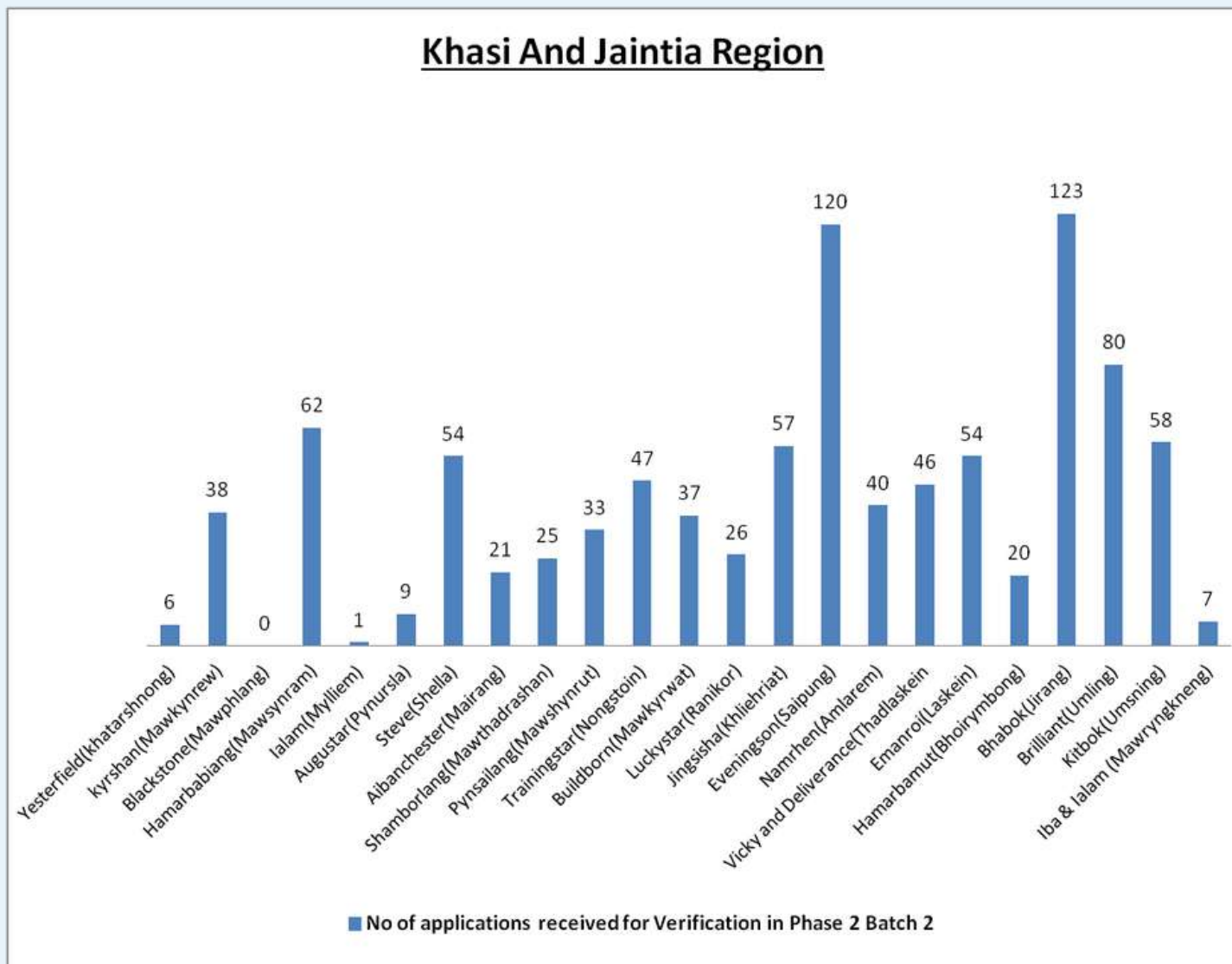

## MEGHALAYA LIVELIHOODS AND ACCESS TO MARKETS PROJECT

### RURAL FINANCE



A two-day workshop on mobilizing the formation of Integrated Village Cooperative Societies (IVCS) under Phase III was recently organized by the Rural Finance Component for Khasi and Ri Bhoi regions on April 14th and 15th, 2023 at MIIT, Shillong and for Jaintia region on April 17th and 18th, 2023, at Hotel Highwind, Thadlaskein. The primary objective of the workshop was to familiarize the staff from all components of the Meghalaya Livelihood and Access to Markets Project (MLAMP) with the process of forming new IVCS in the state.

Building on the success of IVCS formation in the previous two phases of the project, the workshop aimed to scale up the initiative by forming 150 additional IVCS in the state. The workshop provided a platform for knowledge-sharing, capacity-building, and practical training on the mobilization and formation of IVCS, which play a crucial role in promoting rural livelihoods and access to markets.
