Minutes of the Online Meeting on organizing village-level workshops on "Formation of IVCS" under MegLIFE Project

Meghalaya Livelihood Improvement

Date: 02.12.2023 Time: 11:00 am

Background & Context-

MegLIFE Project adopted IVCS approach for implementation of Micro Credit Activity sub component. In view of this it is decided form Integrated Village Cooperative Society (IVCS) clustering 4-6 villages located within a distance of maximum 5-6 km from the centre village to be selected as IVCS office.

In case of non-availability of such villages 3 villages or 2 villages can also be clustered to form IVCS if total number of households of the cluster villages is coming to more than 150.

In this regard an online meting was held on 2nd Dec, 2023 at 11:00 am involving representative from M-LAMP SPMU,

FOCUS SPMU team, all DPMs, BPMs of MegLIFE Project and NGO staff of FOCUS. Shri Larikuper Lyngdoh, M-LAMP SPMU gave presentation on IVCS concept and process of registration. After detail discussion on villages shortlisted for clustering under IVCS in MegLIFE following decisions were taken in this meeting-

Decision

Finalizing Village clusters for formation of IVCS

- Village cluster list as identified will be shared with DPMs.
- DPMs will conduct a district level meeting on 4th Dec,2023 involving district team from M-LAMP and FOCUS and 2. update the final list of IVCS cluster by 4th Dec,2023 itself.

Village level workshop on "Formation of IVCS"

- SPMU will share spread sheet of selected resource persons from M-lAMP and FOCUS with DPMs
- DPMs along with district FOCUS and M-LAMP team will finalize the names of resource persons from FOCUS 2. and M-LAMP in the meeting to be conducted on 4th Dec,2023 and share final list with SPMU
- SPMU will issue notification for conducing village level workshops on "Formation of IVCS" along with model 3. budget and module.
- Tentative deadline for starting the workshop is 11th Dec,2023. 4.
- 2-3 workshops will be conducted simultaneously in a day to complete workshops by 15th Jan, 2024. 5.
- Application for IVCS formation shall also be collected during the workshops so that these could be further 6. processed for registration by Cooperation Dept.
- Representative from cooperation department (Assistant Registrar, Sub Registrar or Senior Cooperative Officer shall 7. be invited in the workshops to ease the registration process.

Identification of Vibrant Producer Groups to be selected as SHG for IGA support under MegLIFE

- Assistant Managers and Program Associates of BPMUs shall be assign the task of identification of good producer groups with active business for shortlisting as viable for formation of SHGs under MegLIFE.
- Assistant Managers and Program Associates of BPMUs shall conduct mobilization meetings with the PGs on formation of SHGs and take the consent of willing PGs to form SHGs.
- Details guidelines for identification and mobilization of PGs will be shared from SPMU. 3.
