In view of the above, closure of the VPICs shall be informed to the villagers officially through notice and the associated bank accounts shall also be closed.


Following this decision, all balance project funds in the aforementioned bank accounts shall be transferred to the concerned DPMU account. The respective DPM should facilitate the process.

In case of VPICs of Umsning BPMU from **Sl. No. 8, 9 & 10** community nurseries shall be maintained till all seedlings are utilized. After that, the account of the VPIC shall be closed and the remaining balance fund shall be deposited to the DPMU account.

In the case of VPICs of Rongara BPMU from **Sl. No. 15 & 16** closure of VPICs shall be informed to the villagers officially through notice.


